(VIA CREDIT REPORT AND CRIMINAL BACKGROUND CHECKS)

The undersigned applicant for a membership at Santa Rosa Golf & Beach Club, Inc. ("the Club") understands that as part of the consideration of the membership proposal, the Club will conduct, and the undersigned hereby authorizes the Club to undertake a background check, including but not limited to an applicant's financial responsibility, reputation and social position, and those same attributes of members of the applicant's family, and to access such information as may be necessary to complete a criminal background check. The background check may include (but is not limited to) criminal records, fingerprints, civil records, driver's license status, credit reports, employment history and electronic searches.

Information obtained as a result of the background check may result in denial of membership.

Periodic investigation of members may occur from time to time as determined by the Board of Directors. For example, an investigation may be commenced should any Board member become aware of an arrest, or an allegation of an arrest of any member or guest associated with a member, so that the Board of Directors may determine whether the member has engaged in activities prejudicial to the best interests of the Club, warranting suspension or cancellation of the membership.

No information or documentation that is gathered during an initial or periodic investigation will be disclosed to the applicant, and the applicant agrees not to make demand upon the Club or any other person for disclosure of such information or documentation.

The undersigned releases, discharges and exonerates any person, agency or entity supplying information and documents about the undersigned to the Club from any and all liability of every nature and kind arising out of the furnishing of such information and documents. The undersigned indemnifies the Club against any liability which may result from making requests for such information and documents, or for employees and members of the Board reviewing or discussing same.

The undersigned agrees that a fax or copy of this Consent and Release with my signature will be accepted with the same authority as the original.

The undersigned certifies that all information provided in the Application and in the attached Personal Information Sheet is accurate, true and correct, and that I fully understand the terms hereof.
